# Release notes

**EudraCT Version: 8.1.0** 

Goal: Release 8.1 Iteration 1

Release Date: 02/08/11

**Environment: Production** 

#### Release Contents:

This is the release to production of the first iteration of EudraCT 8.1. It includes the following main functional changes:

- User Interface improvements to enhance the design of data entry forms, eliminating manual
  data entry on some fields where information can be auto populated based on the information
  provided to earlier questions using enhanced form logic i.e. auto population of data and hiding
  questions where not applicable. (See Additional Information on Enhanced Form Logic below).
  Improved navigation flow to make data entry more consistent and easier to use and fill in.
  Consistent user interface to allow expand / collapse sections of the CTA particularly section D
  that is now accessible in a single view.
- Re-enforcement of the use of the MPD to look-up active substances before necessitating adding them directly in EudraCT.
- New feature for displaying other language field as a default against free text fields.
- Various help text improvements and changes for EEA and Third Country forms.
- Validation Rule improvements to make it more user friendly and to simplify data entry

The release also includes some further changes to address identified defects in the main application.

## Important note regarding Enhanced Form Logic

In v8.1, when specific values are entered into certain fields in an entry form, this will also auto fill other relevant fields without requiring a manual input. The enhanced form logic is based on the following criteria:

- Auto-population of child/dependant fields with the contents of parent fields to make the form sections easier and quicker to fill in, reducing the amount of duplicate data entry.
  - Please note that the auto-population of child/dependent fields is only activated on initial data entry but subsequent changes/corrections of the parent field are not carried over to child fields. For example the initial entry in A.1 Member state in which the submission is being made will be auto-filled in D.2.1.2, Country that granted the MA, however if the user changes the value in A.1, the update will not be cascaded to D.2.1.2.
- For subsequent changes/corrections, the child/dependent fields need to be updated manually they do not change automatically. This approach is taken to avoid users having entered data changed or deleted without their knowledge.
